We hereby inform you that a meeting of the company's board of directors was held on Wednesday, 7 May 2025. The following is a summary of the decisions issued during the meeting:

- The BOD approved the report of the board of directors and the (unaudited) financial statements of the company as of 31st March 2025, along with disclosures, after reviewing the audit committee's report, in preparation for submission to the company's auditor and the Accountability State Authority.
- reconstituting the audit committee.
- The Board approved the disclosure report in accordance with Article 48 of the Listing Rules for the purpose of amending and increasing the issued and paid in capital from EGP 1,814,400,000 to EGP 2,268,000,000, an increase of EGP 453,600,000 through the issuance of 226,800,000 shares at a nominal value of EGP 2 per share, at a ratio of 1 share for every 4 shares. This increase is to be financed from the company's profits for the fiscal year 2024, as reflected in the financial statements for the period ending 31/12/2024, accompanied by the auditor's report and approved by the company's Ordinary General Assembly held on 10/4/2025.
- Amendment of Articles (6, 7) of the company's Articles of Association.
- The board authorized the Chairman of the board to take all necessary actions and decisions to invite the Extraordinary General Assembly to proceed with the amendment procedures and obtain all necessary approvals. Additionally, he is authorized to make amendments as required by the Egyptian Exchange and relevant regulatory authorities on the disclosure report.

The company acknowledges that the above summary includes all essential information that must be disclosed in accordance with the provisions of the Capital Market Law, its executive regulations, and the rules and decisions issued in implementation thereof.
